15. Brief Description of the Assignment:

INFORMATION FOR APPLICANT

Bangladesh Satellite Company Limited (BSCL) intends to start an initiative to deploy/ install 300 Audience End Devices/ Television Rating Point (TRP) devices in the whole country. According to the tenderer survey and convincing capacity, these 300 devices need to be deployed/ installed. Under the terms and conditions set by the BSCL, the tenderer must deploy/ install the TRP device throughout Bangladesh and provide post-deployment assistance per device.

16. Experience, Resources & Delivery Required:

- a) The tenderer must have experience of conducting at least two surveys at the household level over the last 5 years.
- b) The tenderer must have experience of designing methodology (sampling techniques, sample size determination, sample allocation, data analysis plan) of at least 2 studies over the last 5 years.
- c) The data collector panels of the tenderer need to have a minimum of five years of expertise in field-level data collection.
- d) The management panel must have at least one member with educational backgrounds in statistics
- e) The tenderer needs to have at least 05 training experience in Survey/Research/data analysis
- f) Require expertise in developing survey reports in both English and Bangla
- g) Ability to obtain various papers, data, and information from the Bangladesh Bureau of Statistics (BBS) if required.
- h) Digital data (ODK, Kobo tool box) collection and real-time monitoring experience.
- i) Knowledge of TRP devices is advantageous.
