Terms of Reference

<u>Technical Specification of Feasibility Study for Demarcation, Pole Establishment, Design</u> and Estimation for Construction of Boundary Wall and Warehouse at Sajeeb Wazed Satellite Ground Station, Gazipur.

Background of the project:

Bangladesh Satellite Company Limited (BSCL) requires to build a boundary wall around 13-acre land and a warehouse (approximately 2000 sq feet) at Gazipur ground station. In this regard, BSCL wants to procure "Consultancy Service" from eligible "Consultancy Firm" to prepare the architectural & construction engineering design and to estimate the cost of construction.

Objectives of the assignment:

To prepare the architectural & construction engineering design and to estimate the cost of construction to build a boundary wall and a warehouse at Gazipur ground station.

Scope of Services: The scope of the works of the consultant is as follows:

<u>Job 1:</u>

The consultant will have to do the following preparatory works to prepare the architectural & construction engineering design of the proposed construction of boundary wall and that of proposed ware-house like (but not limited to):

- a. Conduct digital survey of the land.
- b. Measuring the length of the proposed boundary wall
- c. Mark the position and area of the proposed warehouse considering the access facility.
- d. Performing soil test of the site.
- e. Prepare design and drawing of proposed boundary wall.
- f. Prepare design and drawing of proposed ware house.
- g. Prepare cost estimation of the construction as per the formulated design and drawing of proposed boundary wall.
- h. Prepare cost estimation of the construction as per the formulated design and drawing of proposed ware house.
- i. Others (whatever required to prepare the design and drawing of proposed boundary wall and that of the proposed ware house).

<u>Job 2:</u>

Prepare appropriate Standard Tender Document (STD) with detail Technical Specification for procuring the construction works as per the design and drawing of the proposed ware house as formulated in Job 1.
